The Blue Bird Circle Resale Shop (the "Shop") accepts for consignment household goods and furniture items that meet the following requirements:

Consignor **must furnish a list with complete descriptions of all items that constitute each consignment.** Each furniture contract must be valued at a total of at least \$50.00 and each item must be priceable for at least \$5.00. Furniture items must be clean and in good condition. **PLEASE REFER TO THE FURNITURE RECEIVING INFORMATION SHEET** posted in the receiving area and on our website for complete details of items that are not acceptable for consignment.

Consignor agrees that it is the exclusive right of the Shop (1) to determine if the items brought to the Shop by a consignor meet the Shop's requirements (2) to determine the price of all items in consignments (3) to determine the markdown policy. Furniture contracts expire three (3) months from the date the consignment was priced.

Consignor will be paid 60% of the selling price of all items sold during the contract period and will be paid by mailed check only. **There is a \$10.00 minimum on consignment checks; lesser amounts may accumulate and pay at a later date.** A \$1.00 processing/handling fee per check will be deducted from each consignor check issued. **There is a \$5.00 replacement fee for missing or lost checks, up to one (1) year from issuance. Checks uncashed after one (1) year of the date of issuance will not be replaced, but will be treated as a "Shop" donation. If a party other than the consignor delivers a consignment, it will not be accepted without a signed contract and complete list of items.**

The consignor agrees and acknowledges that The Blue Bird Circle, the Shop and its Officers, Directors, Agents, Employees and Volunteers assume no responsibility nor liability for the loss or damage to the goods consigned by consignor to the Shop, including, without limitation, any such loss or damage occasioned by negligence.

***\*\*The consignor agrees that any consigned items that cannot be priced by the Shop or those items that have not sold within the dating period of a contract will automatically, and with no notice to the consignor, become items irrevocably donated by the consignor to the Shop and the consignor will have no further interest in such donated items.***
